Discussion was held on the proposed 2016-2017 budget. Motion was made by Trustee Blondell 2nd by Trustee Lincoln to close the public hearing at 7:15 p.m. All members present voting AYE.

Motion was made by Trustee Lincoln 2nd by Trustee Blondell to accept the 2016-2017 budget. Mayor Hunter called for a roll call vote which resulted in Trustee Lincoln voting AYE, Trustee Kumkey voting AYE, Trustee Blondell voting AYE, Trustee Linsner voting AYE and Mayor Hunter voting AYE. Carried.
